Ming Chuan University Study Requirements for Risk Management and Insurance Department

Regulations for graduate students

Passed at the Academic Affairs Committee Meeting on May 12, 2011

- 1. The main purpose of these regulations is to encourage students to truly cultivate their virtue and characters, and to acquire knowledge from what they study at university.
- 2. The prerequisite course of graduate student is Risk Management and Insurance related courses. Those who qualify for following conditions are allowed to waive the perquisite courses:
 - (1) Earn minimum of 4 credits from related undergraduate courses and with minimum score of 70.
 - (2) Earn higher than average score of Insurance Theory and Practice Entry Exam.
 - (3) Take the related courses from undergraduate program and with minimum score of 70.
- 3. Before selecting classes for their first semester of study, new students should get the approval of their class advisor and department director; experienced students who have the approval of their advisor and department director are allowed to proceed with course selection.
- 4. According to legal regulations, it is necessary for graduate students who have completed pre-study courses and such credits recorded, to obtain the permission of the department director to waive credits (maximum of 1/3 of total required credits, excluding master's thesis). Credit waivers must be applied for within the first two weeks of the first semester. Late applications are not accepted.
- 5. Graduate students must apply to select their academic advisors for thesis within the first year of study. After approval, unless there are some significant reasons approved by the original advisor and director, students are not allowed to change advisors.
- 6. Academic advisors should be a full-time faculty in this department. For special thesis research topics, the department director engages another university's faculty member as a thesis advisor, but at least one full-time faculty member of the department most co-advise the research.
- 7. Master's students must complete 47 credits for graduation (including required, elective subjects and thesis, excluding prerequisites).
- 8. Graduate students are required to pass English tests in accordance with Ming Chung University Procedures for English Proficiency before the beginning of the 2nd semester year. These who fail are eligible to graduate only after they take relevant courses and meet the requirements stated.

- 9. Master's students must earn at least 19 credits before making their thesis proposal (excluding prerequisite courses).
- 10. Master's students must earn at least 30 credits before submitting their thesis draft for review (excluding prerequisite courses).
- 11. Master's students need to take at least 3 credits per semester (excluding prerequisite courses and English). Those who have already completed the two years of normal study are not restricted.
- 12. The master's degree exam committee will be composed of 3 to 5 people, with 1/3 or more of committee members from other schools. The department director recommends exam committee members for the president's approval prior to the oral exam. The student's academic advisor cannot be on the committee.
- 13. Graduate students should refer to the "Master's Thesis Writing Guidelines" when writing.
- 14. Other matters not specified in these regulations will be handled in accordance with relevant school regulations.
- 15. These regulations were approved by the department affairs committee, school affairs committee and university Academic Affairs committee and are implemented after informing the university authorities. Amendments must be handled accordingly.
